


# CANYON FURNITURE COMPANY

6.- TAKE 3 DRW STUDENT LOFT DESK (C) AND 5 DRW STUDENT LOFT CHEST (D), PLACED THEM IN DESIRED POSITION IN THE ROOM, (PLACE FRONT FACE OF DESK OUTWARDS)

7.- INSERT ONE METAL DOWEL PIN (B) IN EACH OUTSIDE CORNER OF 3 DRW LOFT DESK AND 5 DRW LOFT CHEST, SEE FIG.11

8.- TAKE THE ASSEMBLED TWIN UPPER BUNK BED, PLACE IT ON TOP OF BOTH CASES, ALIGNING THE METAL DOWEL PINS WITH EACH PRE- DRILLED HOLE IN EVERY CORNER OF THE BED UNTIL THE METAL DOWEL PIN ARE ALL THE WAY IN THE HOLES OF THE BED, SEE FIG.12

9.- ALIGN THE PRE - DRILLED HOLES IN LONG PART OF METAL HOOKS BRACKETS (L) WITH THE PRE-DRILLED HOLES IN THE LADDER (K), SECURE WITH 1" SCREWS (M) USING PHILLIP HEADSCREWDRIVER ( NOT INCLUDED ), SEE FIG.C AND HOOK THE LADDER IN THE PROPER POSITION, ADJUST AND ALIGN THE PRE-DRILLED HOLES IN THE SHORT PART OF METAL HOOKS ON TOP GUARDRAIL AND SECURE THE LADDER, AS SHOWN IN CONFIGURATION TYPE # 2

# SAFETY WARNINGS

1.- FOLLOW THE INFORMATION ON THE WARNINGS APPEARING ON THE UPPER BUNK END STRUCTURE AND ON THE CARTON. DO NOT REMOVE WARNING LABEL FROM BED.

2.- ALWAYS USE THE RECOMMENDED SIZE MATTRESS OR MATTRESS SUPPORT, OR BOTH TO HELP PREVENT THE LIKELIHOOD OF ENTRAPMENT OR FALLS.

3.- SURFACE OF MATTRESS MUST BE AT LEAST 5 IN BELOW THE UPPER EDGE OF GUARDRAILS.

4.- DO NOT ALLOW CHILDREN UNDER 6 YEARS OF AGE TO USE THE UPPER BUNK.

5.- PROHIBIT MORE THAN ONE PERSON ON UPPER BUNK.

6.- PERIODICALLY CHECK AND ENSURE THAT THE GUARDRAIL, LADDER AND OTHER COMPONENTS ARE IN THEIR PROPER POSITION, FREE FROM DAMAGE, AND THAT ALL CONNECTORS ARE TIGHT.

7.- DO NOT ALLOW HORSEPLAY ON OR UNDER THE BED AND PROHIBIT JUMPING ON THE BED.

8.- ALWAYS USE THE LADDER FOR ENTERING AND LEAVING THE UPPER BUNK.

9.- DO NOT USE SUBSTITUTE PARTS. CONTACT THE MANUFACTURER OR DEALER FOR REPLACEMENT PARTS.

10.- USE OF A NIGHT LIGHT MAY PROVIDE ADDED SAFETY PRECAUTION FOR A CHILD USING THE UPPER BUNK.

11 .- IF THE BUNK BED WILL BE PLACED NEXT TO THE WALL THE GUARDRAIL THAT RUNS THE FULL LENGTH OF THE BED SHOULD BE PLACED AGAINST THE WALL TO PREVENT, ENTRAPMENT BETWEEN THE BED AND THE WALL.

12.- ALWAYS USE GUARDRAILS ON BOTH LONG SIDES OF THE UPPER BUNK.

13.- THE USE OF WATER OR SLEEP FLOTATION MATTRESSES IS PROHIBITED.

14.- STRANGULATION HAZARD. NEVER ATTACH OR HANG ITEMS TO ANY PART OF THE BUNK BED THAT ARE NOT DESIGNED FOR USE WITH THE BED, FOR EXAMPLE, BUT NOT LIMITED TO HOOKS, BELTS AND JUMP ROPES.

15.- KEEP THESE INSTRUCTIONS FOR FUTURE REFERENCE.

### SIZE OF MATTRESS AND FOUNDATION

THE UPPER AND LOWER BUNK BED IS DESIGNED TO USE ONLY MATTRESS WHICH IS 74" TO 75" LONG AND 37 1/2"TO 38 1/2" WIDE FOR TWIN BED. THE UPPER AND LOWER BUNK BED IS DESIGNED TO USE ONLY MATTRESS WHICH IS 74" TO 75" LONG AND 57 1/2"TO 58 1/2" WIDE FOR FULL BED.

THE BUNKIE BOARD IS REQUIRED TO 37 1/2" WIDE X 74" LONG FOR TWIN BED AND 57 1/2" WIDE X 74" LONG FOR FULL BED.

NOTE: ENSURE THICKNESS OF MATTRESS AND FOUNDATION COMBINED DOES NOT EXCEED 8 1/2" AND MATTRESS IS AT LEAST 5" BELOW UPPER EDGE OF GUARDRAILS.
